I will not enter into an agreement with my Employer to receive a wage that is lower than the prevailing minimum allowable wage announced by the Government of the Hong Kong Special Administrative Region at the date of and stated in the employment contract (D. H. Contract No. _____);

Employers who have obtained the Director of Immigration's approval before 1 April 2003 to let their Helpers live out can continue to do so, so long as they continue to employ Helpers without a break of more than 6 months.
